James Scarborough Theodore Pollard (1889 – 1919)

James Pollard was from a large and established Farnhill family. His mother died when he was seven years old and, after attending Kildwick School, James worked in one of the local mills.

Assigned to a battalion of the Duke of Wellington's Regiment he went to France in 1916 and his service record, in 1918, showed him as being a drummer.

Continuing to serve with the army after Armistice he was finally demobilized in October 1919. He did not live very long to enjoy civilian life as he died of double pneumonia shortly afterwards. He was buried in Kildwick churchyard and his name recorded on the Kildwick War Memorial.

Pre-war life

James Pollard was born in Farnhill on 28th June 1889, the fourth son (and fifth child altogether) of an established local family.

His father was Theodore Pollard, born Farnhill in 1854; his mother, Priscilla, born in Glusburn, also in 1854, was the illegitimate daughter of Margaret Brown – who married James Walmsley in 1856.

James was born to an already large family, which was continuing to grow. Theodore and Priscilla would have a total of 10 children altogether:

- John; b. 18/5/1885
- Martha Ann; b. 20/6/1887
- James Scarborough Theodore Pollard; b. 28/6/1889

- Harry; b. 28/11/1894
- two others, names unknown, who died prior to 1911

On the 1891 census, James Pollard, aged one, was recorded as living with his parents and sisters, Martha Ann and Sarah Margaret, in High Farnhill.

Priscilla Pollard died, in Farnhill, on 24th February 1897 and was buried in Kildwick churchyard three days later. She was aged 42 or 43; James was aged just 7.

The 1901 census gave the family's address as 42 Main Street.

The family later moved to the Arbour, some time prior to the 1911 census.

James attended Kildwick school and at Christmas 1901, when he would have been aged 12, he took part in the annual school concert.

This must have been close to the end of his school career, as most children did part-time work from age 12 and left school at 14; usually to work in one of the local mills

The 1911 census recorded James, aged 21, as a "Cotton Weaver".

WW1 service

James attested his willingness to serve on 11th December 1915 and was almost immediately assigned to the reserve unit, the 3/5th battalion Duke of Wellington's (West Riding) Regiment.

A medical examination carried out when James joined his battalion, on 15th February 1916, recorded that he was 5 feet 4¾ inches tall (164 cm) and weighed 105 lbs (47.6 kg). He also had an interesting distinguishing feature: a "Buffalo Bill tattoo" on his right arm.

James was transferred to the $1/5^{th}$ battalion in June 1916 and was shipped over to France on the 16^{th} – he was one of over 300 men who joined the battalion in the field that month.

James' name was recorded on Farnhill Methodist Chapel's Roll of Honour, which also includes the names of his brothers – John, Harry and Frank. This was unveiled on 9th July 1916, by which time James was already serving in France.

The service records for James Pollard have survived, although they do not provide much information on how he fared in the war, and there were no specific references to him in this period in the local newspapers.

It is clear that James was transferred from 1/5 battalion to 2/5 towards the end of January 1918, but at the end of the month both battalions were merged anyway, to form a single 5th battalion.

His service record shows that he was appointed "Drummer" on 16th February 1918.

He was given leave in England from 8th to 22nd October 1918 and during this period he paid a visit to his old school.

James continued to serve with the army after the armistice and was with the 5th battalion when it was moved to Germany. On 10th March 1919 he was transferred to 2/4 battalion, as recorded in the Regimental War Diary:

March 10th 1919: The retainable men of the battalion (those joining the colours subsequent to 1st Jany. 1916) were transferred to 2/4th. Duke of Wellington's Regt. and marched to ZULPICH [near Bonn]. In all yesterday and to-day 12 officers and 298 other ranks were transferred.

More leave in England was granted between 26th May and 9th June 1919, before James was finally sent home for the last time in September 1919. He was finally demobilized on 2nd October 1919.

Post-war life

James returned to his old family home in the Arbour, which was occupied by his sister, Martha Ann, and her husband Sam Tillotson. (James was a witness at their wedding, in Kildwick Church, on 27th December 1915.)

When James left the army dispersal camp in Ripon on 4th September 1919 his discharge certificate recorded his medical condition as A1. However it appears that he was not very well, as shortly afterwards his brother-in-law, Sam Tillotson, wrote the following (undated) letter to the Army.

Dear Sir,

No. 241472 Pte. J.S.T. Pollard 2/4 Duke of W. Reg. has been in very poor health since being demobilized & as there is no Military Hospital within the four miles we have been obliged to call in a local Doctor. The above named is at now suffering with a very serious attack of pneumonia with the Dr. attending frequently daily. His claims for attention I suppose will be sent you in due course.

James Scarborough Theodore Pollard died of double pneumonia on 7th October 1919 and was buried in Kildwick churchyard, in the family plot, a few days later. He was aged 30.




Part of the kerbstone of the Pollard family plot – commemorating James Pollard

Postscript

Early in 1920 letters of administration were granted to William, James' oldest brother to enable him to settle his affairs. James Pollard's total effects were valued at £97-2s-7d.

On 7th December 1920 James' sister, Martha Ann Tillotson, signed a receipt for the British War Medal and Victory Medal awarded to him for his war service.
